A. Budget 2020-21 M/S/C (Wells/Figueroa). Unanimous vote a approve option B budget with an additional \$10,000 community project item.

Crowson said that the budget as presented contains two options for the Board of Directors to select/modify. Due to recent inquiries by the Riverside County Grand Jury into the operations of the District, it is staff recommendations that the District seriously considers the idea of a reduction in service via the General Fund. Option one of the proposed budget allows for the continuation of law enforcement services at the current rate. Option two of the proposed budget allows for the continuation of supplemental service but at a reduced cost and at a reduced number of law enforcement personnel. This being the time and place for public hearing those wishing please come forward, state name, address, parcel number and nature of protest, Crowson said.

Bran Anderson noticed no public forums to get public participation. Wells said "we have tried public forums in the past with zero participation." Crowson said we advertise this and this public meeting. Luna, for some time he has researched and is concern about this District's organizational procedures. On August 25th., The Board of Supervisors will call to approve a five year law agreement for law enforcement services in the amount of 4.1 million dollars. He summits the following: first, initiate a motion to for this board of directors to resign and forgo any action as a representative body; second, submit to the board of supervisors a petition of voluntary resignation; third, submit a request to board of supervisors to assume future authority for governance of this District; Fourth, retain office at 91260 Avenue 66; fifth, hire a full time county employee, and recommends current office representative Brenda Ortiz. Luna thanks everyone for listening. Broughton closed public hearing. Crowson stated that option one is the temporarily voted on option; two full time deputies and a full time sergeant. Services at the this rate will result in over budget scenario. Option two allows for continuation of services and it is up to Lt. Martinez to decide what the most cost and service effective way to go about this. This will be a constantly monitor level of service, Crowson said. Considering the current situation, his recommendation is to pass option B, he added. Wells stated "we know this was coming, and this breaks my heart to consider a reduction in services." Frank said he does not

see any budgeted item for environmental services. Crowson said that a great option to consider at this time. Line item for Community project for \$10,000 will be added.
